## THE VITA PROGRAM PREPARES SIMPLE RETURNS FOR FREE!

### WHAT KINDS OF RETURNS CAN VITA DO?

-  People who generally make \$60,000 or less
-  People with Social Security, including seniors and those with disabilities
-  U.S. Citizens, U.S. Nationals, and students, teachers, and trainees with F, M, J or Q Visas
-  Those with regular income, investment income, dividend income, and retirement accounts
-  People wanting tax benefits from dependents, education, or income level

### WHAT DO YOU NEED?

- **Driver's License, State Photo ID,** or other official proof of identity with a picture
- **Social Security cards** for **you**, your **spouse**, and any **dependents**
- **Wages and earnings statements** like a W-2, 1099-Int, 1099-Misc, etc.
- Any other **tax documents** you received
